The Board wishes to inform the Shareholders and potential investors that the Group is expected to record a substantial loss for the year ended 31 March 2012. These losses are mainly attributable to (i) decline in profitability of the Group's CDM business; and (ii) loss incurred by the Group's retail operations.

As the Company is still in the process of finalizing the results for the year ended 31

March 2012, the information contained in this announcement is only based on the preliminary review on the management accounts of the Group, which has not been confirmed nor reviewed by the Company's auditor. Shareholders of the Company and potential investors should read the Group's financial results announcement for the year ended 31 March 2012 carefully, which is expected to be published in late June 2012.
